#### **CORPORATE GOVERNANCE**

**The Statutory Audit Committee:** The audit committee held three meets during the year; 25/03/2019; 19/07/2019; 21/10/2019; to perform their roles and responsibilities as stated in section 359(6) of the CAMA, 2004, and the Nigerian code of Corporate Governance (2018). The members are Segun Layode, Gaius Ike, Ibrahim Bauch and Chris Ekemezie.

Apart from the Board Audit Committee, the company also has the Risk Management committee, the Strategy Committee, and the General Purpose Committee.

**The Risk Management committee**: Focuses on the risks, opportunities and threats prevalent in the organization's operating environment. The committee sits quarterly to appraise the impact of such factors and make recommendations to the board. Members of the committee are, Mr. Segun Layode, Mrs Chinelo Igwe, Mr Ike Gaius and Mr Chris Ekemezie.

**The Strategy Committee** Is charged with evaluating the organization's business strategy in accordance with regulatory, economic and political realities. The committee meets quarterly to appraise the changes in the business climate, and reports to the Board. They are made up of, Mr Gaius Ike, Mr Chris Ekemezie, Alhaji Ibrahim Bauchi and Mr Segun Layode.

**The General Purpose Committee**: Oversees all other aspects of the organization's business activities. This includes but not limited to, Human Resources issues, Third Party engagements and contracting, acquisitions and branch development. This committee meets quarterly and makes their recommendation to the board for approval. The General Purpose Committee members are, Mr Chris Ekemezie, Mrs Chinelo Igwe, Alhaji Ibrahim Bauchi and Mr Segun Layode.

#### COMPLAINTS MANAGEMENT POLICY FRAMEWORK

The complaints management policy of Anino International Plc has been prepared pursuant to the requirement of the Securities and Exchange Commission's rules relating to the complaints management framework of the Nigerian Capital Market.

The policy has been prepared in recognition of the importance of effective engagement in promoting shareholder/investor confidence in the company. This policy sets out the framework by which the company and its Registrar provide assistance regarding shareholder issues and concerns. It also provides opportunity for shareholders to provide feedback to the company on matters that affect shareholders.

This policy relates only to shareholders of Anino International Plc and is designed to ensure that complaints and enquiries are managed in a timely manner.

#### **GUIDING PRINCIPLES FOR MANAGING COMPLAINTS**

- 1. **CONFIDENTIALITY:** All complaints shall be handled in strict confidence and all personal information of the complainant would be adequately protected.
- 2. **MODE OF MAKING COMPLAINTS/ENQUIRIES:** A complaint lodgement form would be made available to all shareholders to state their complaints /enquiries and access relevant information in the following manner:
  - a. Contact Register: Shareholders who wish to make a complaint/enquiry shall in the first instance contact the Registrar, Apel Capital and Trust (Registrars) Limited at 8, Alhaji Bashorun Street, South West Ikoyi, Lagos. The Registrar manages all the registered information relating to all the shareholdings, including shareholder names, addresses and dividend payment instructions among others. Upon receipt of a complaint/enquiry, Anino International Plc would be notified of such monitoring, and record keeping.
  - **b.** Contact Company Secretary: If the registrar is unable to satisfactorily address the shareholder's complaint, then the shareholder should contact the office of the company secretary.
- 3. FEEDBACK : Where a complaint/enquiry is sent directly to the company, Anino International Plc shall upon receipt of the complaint/enquiry use its best endeavours in ensuring that: i The complaint/enquiry is recorded ii Prompt and timely response is given to the complaint iii The NSE is promptly notified of the complaint/enquiry iv Notify the shareholder promptly if complaint/enquiry cannot be treated immediately
- 4. **FORM OF COMPLAINT /ENQUIRY REGISTER:** The complaint register shall be in an electronic form composed of the following:
  - **a.** The date of the complaint
  - **b.** The details/information of the complainant
  - c. The nature/description of the complaint
  - d. The steps/actions taken to resolve the complaint

This policy shall be made available on company's website (<u>www.aninoplc.com.ng</u>) the Registrars and by contacting the office of the company secretary of Anino International Plc.

5. The Complaints Management Policy is subject to review from time to time by the company.

#### SECURITIES TRADING POLICY

In line with rule 17:15 of the Disclosure of Dealings in Issuer's Shares, Rule Book of the Exchange, Anino International Plc has a trading policy which applies to all the employees and directors who may at a time possess any insider or material information about the company.

#### STATEMENT OF DIRECTOR'S RESPONSIBILITY FOR THE YEAR ENDED 31<sup>ST</sup> DECEMBER 2019

In accordance with the provision of the Companies and Allied matters Act, the Directors are required to prepare financial statements for the year which gives a true and fair view of the state of financial affairs of the company:

- a. Keeps proper Accounting records which discloses with reasonable accuracy, at any time, the financial position of the company;
- b. Prepares the financial statements in compliance with the provision of the Companies and Allied Matters Act as well as the International Financial Reporting Standards.

c. Establishes adequate internal control to safeguard its assets and to prevent and detect fraud and other irregularities.



iii The NSE is promptly notified of the complaint/enquiry

iv Notify the shareholder promptly if complaint/enquiry cannot be treated immediately

Each year, the committee evaluates the qualifications, performance and independence of the company's independent auditor and determines whether to re-engage the current independent auditor. In doing so the audit committee considers the quality and efficiency of the services provided by the auditors, the auditors' capabilities and the auditors' technical expertise and knowledge of the company's operation and industry. Based on this evaluation, the audit committee has retained Muyiwa & Co. as the company's independent auditor for 2017. This firm has been the independent auditors of the company since 2009.

The members of the audit committee and the board believe that, due to Muyiwa & Co's knowledge of the company and of the industry in which the company operates, it is in the best of interest of the company and its shareholders to continue retention of Muyiwa & Co. to serve as the company's independent auditors. Although the audit committee has the sole authority to appoint the independent auditors, the audit committee will continue to recommend that the board ask shareholders at the Annual General Meeting to ratify the appointment of the independent auditors.

The committee reviewed with the independent auditors, which is responsible for expressing an opinion on the conformity of those audited financial statements with the Nigerian generally accepted accounting principles, its judgment as to the quality and acceptability of the company's accounting principles and such other matters as are required to be discussed with the committee. In addition the committee has discussed with the independent auditor the firms independence from company management and the company, including the compatibility of non-audit services with the independent auditors independence.

The committee also reviewed and discussed together with management and the independent auditor, the company's financial statements for the year ended December 31, 2016, and the result of managements assessment of the effectiveness of the company's internal control over financial reporting and the independent auditors audit of internal control over financial reporting. The committee discussed with the management and the independent auditor, material weaknesses and significant deficiencies identified during the course of the assessment and audit and managements plan to remediate those control deficiencies.

In reliance on the reviews and discussions referred to above, the committee recommended to the board of directors and the board has approved that the audited financial statements and managements assessment of the effectiveness of the company's internal control over financial reporting be incorporated by reference in the annual report for the year ended December 31, 2016.
